## Memorandum of the regulation BUNGALOW and MOBILE HOME

- 1. The bungalow can be occupied after 4.30 p.m on arrival day and must be left within 10.00 a.m. on departure day.
- 2. At arrival a deposit of 50 Euros is required. It will be given back, totally or partially, at departure time.
- 3. Upon arrival, guest have to pay the total amount of the booked stay. An early departure does not entitle to any reimbursement
- 4. Price includes the stay of people, electricity, water, gas and parking for one vehicle. If the bungalow is occupied by more people than reserved for, additional guests will pay an extra charge.
- 5. Linens (sheets, blankets, towels, etc.) must be brought by guests themselves. On request and with additional charge, management can provide them.
- 6. Bungalow is equipped with air conditioning/heating (with extra charge)
- 7. A bungalow which has been reserved, but not occupied, will be kept available for no more than 2 days after the date requested in the reservation. After that period, the reservation will be considered as cancelled to all intents and purposes. In case of late arrival due to any circumstances, the entire booked period must be paid.
- 8. The bungalow must be kept clean and in good order. On request and with additional charge, management can provide final cleaning. In any case, kitchen must be clean on departure day.
- 9. Pets are not allowed into the bungalow.
- 10. To book a bungalow, customer have to pay in advance a 30% deposit of the amount due for the entire booked period, within 10 days since sending of this form.
- 11. In case of cancellation within 30 days before arrival, a refund of 50% of the amount paid as a deposit (excluding sending fees) will be given, otherwise the deposit will not be returned.
- 12. Date changes and cancellations have to be done only by fax, letter and email.
- 13. In case of special offers, management reserves the right to apply different conditions, which will be repeated each time in the booking confirmation's letter.
- 14. Management reserves the right to change assigned accommodation, always keeping in mind the need of the guests' needs, if possible.
